The number of beneficiaries Community Chest supports through social service programmes has grown from 22,000 in 1983 to more than 340,000 beneficiaries today. Last year, donations ensured that more than 5,000 children with special needs continued to receive an education, helped over 21,000 individuals and families in need to achieve better self-reliance and stability, and supported over 2,000 seniors to meet their basic daily needs. This year, the fund-raising arm of the National Council of Social Service needs to raise \$52.6 million to support 157 social service programmes.
